Preferential Procurement Policy framework Act No.5 of 2000: Preferential Procurement Regulations 2017 and Supply Chain Management Policy of Metrobus will apply in the adjudication process. Bidders who do not submit B-BBEE Status T Level Verification Certificates or are non-compliant contributors to B-BBEE do not qualify for preference points for B-BBEE but will not be disqualified from the bidding process. They will score points out of 90 or 80 for price only and **zero** points out of 10 or 20 for B-BBEE

Price should be VAT Inclusive. A valid original Tax Clearance Certificate, PIN Certificate , certified identification copy or company registration certificate, MBD1; MBD2; MBD3.1; MBD4; MBD5; MBD6.1; MBD7.1; MBD7.2; MBD7.3; MBD8 & MBD9 and current municipal account (not more than 90 days in arrears) / lease agreement must be attached or Avadavat may be attached. Failure to attach the requested documents or incomplete tender document will result in a bid being non-res may responsive

All bidders should be registered with the Central Supplier Database and a report thereof should be attached.

Tenders duly endorsed **"BID NUMBER AND DESCRIPTION."** must be placed in the tender box on or before **21 April 2017 @11:00am** at the Metrobus Offices, No 1 Raikes Street Braamfontein.
